IX. RECURRING MATTERS AND DEFERRED ITEMS

A. Delgado Community College Acceptance of Courses for Educational Requirements for the CPA Exam ***

At the November 2012 Board Meeting the Board deferred action on this matter until a later Board Meeting. Executive Director Mrs. Saux and LCPA Executive Director Mr. Gitz will discuss.

B. Report on NASBA Items

1. Recommendations for NASBA Leadership Positions

The Board's office received several e-mails asking for support for the candidacy as **Vice Chair** of NASBA for the 2014-15 year on behalf of several individuals: Janice Gray (Oklahoma) and Donald H. Burkett (South Carolina).

NASBA's nomination committee has since reported that Donald H. Burkett (South Carolina) was chosen as the nominee for Vice Chair.

The Board's office received several e-mails asking for support for the candidacy as **NASBA Director-At-Large** on behalf of several individuals: Jimmy E. Burkes (Mississippi), Carlos Barrera (Texas), Rick Reisig (Montana), and Laurie Tish (Oregon).

The Board's office received several e-mails asking for support for the candidacy as **NASBA Southwest Region Director** on behalf of Coalter Baker (Texas).

The Board's office received several e-mails asking for support for the candidacy as **NASBA Great Lakes Regional Director** on behalf of W. Michael Fritz (Ohio).

The Board's office received several e-mails asking for support for the candidacy as **NASBA Central Regional Director** on behalf of Rodney Van Norden (Kansas).

The Board had previously considered that it would not send letters of support for NASBA candidates given that Mr. Tham serves on the NASBA Nominating Committee until October 31, 2015 and will review all candidates impartially.

2. Report on other NASBA items

Mrs. Saux reported on the topics discussed at NASBA's Executive Director conference in Savannah, GA in March.

- Completing background checks on candidates and passing costs onto applicants (several states are already doing this due to public/taxpayer demands)
- The 10 year review and evaluation of the CPA exam is starting by AICPA with emphasis on using knowledge rather than testing knowledge. The analysis is expected to be complete in the next two years.
- CPE was discussed at the conference with an eye towards future trends and delivery methods.

Mrs. Benefield reported on the topics discussed at the NASBA's Legal Counsel conference in Savannah, GA in March.

- Recent rulings in Louisiana were cited as examples at the conference
- Developed relationships with other Boards' legal counsel for future resources

C. Society of Louisiana CPAs (LCPA)

Mr. Gitz, CPA, LCPA Executive Director, reported on other matters of interest to the Board and the profession including an update on progress with the LED's need to audit tax

Board and the profession including an update on progress with the LED's need to audit tax credit filings, and AICPA's discussions on peer reviews of the future.

D. CAVU (Iron Data, LLC) e-License Software

Mrs. Saux informed the Board the plan to upgrade is moving forward but the original May 1, 2014 deadline has been delayed. New workstations were delivered the week of April 21st.

E. Committee to Review Legislation Proposed by the Legislative Auditor

Mr. Gitz met with LLA members and at this time the matter has been resolved.

X. CPE ITEMS

A. Reporting of CPE Electronically

At the November 2012 Board Meeting, the Board directed that this matter be included on the Board's future meeting agendas in order that progress can be tracked to ensure electronic reporting in the future.

B. CPE Rules Committee - Revision of Board Rules Regarding CPE

The Board's CPE Rules Committee (Mr. Bruno, Mrs. Honoré Thomas, and Mrs. Hutchinson) met via a conference call with Mrs. Saux on April 4, 2014 to discuss the Committee's work to date. A follow up conference is scheduled for May 22, 2014.

The Board discussed and would like the Committee to review:

- moving to annual reporting 40 hours per year;
- possibility of rollover hours;
- the possibility of a license status with less CPE requirements due to retirement or age plus years of practice; and
- whether other states define or have different parameters for CPE.

C. Audit of 2010 - 2012 CPE Reporting Forms

Compliance Investigator Carolyn Wainright is conducting the audit of CPE reporting forms for the 2010 - 2012 reporting period. A total of 175 CPE forms were randomly selected for audit.

All of the initial submissions have been reviewed, with the following results:

133 PASSED (80 no deficiencies or problems; 53 with disqualified hours)

40 FAILED (further review is ongoing)

<u>2</u> dropped (previously audited in prior reporting cycle)

175 Total Audits selected

Ms. Wainright discussed the following patterns she noticed:

- record keeping is poor because the review is over a span of 3 years;
- individuals are dependent on employer to keep track and sometimes are no longer employed with that company;
- individuals have difficulty in understanding rules and requirements; and
- creativity in submissions which can be resolved with a better reporting form from the Board.

Mrs. Saux will perform the second review on the 40 failed submissions sited above.

Chairman Tham pointed out it is the responsibility of the individual to compile a complete and accurate report of their CPE. If information is missing or incomplete, the report should be returned to the individual for completion.

XI. NEW MATTERS

A. Renewal of Contracts for Current PROC Members

Mrs. Saux presented to the Board contracts for the current PROC members Mr. Lewis, Mr. Updegraff, and Mr. Parker for the July 1, 2014-June 30, 2015 fiscal year. The contracts are for \$150 per hour plus expenses with a maximum of \$6,000 as budgeted. The Board reviewed the contracts.

Upon motion by Mr. Bergeron, seconded by Mrs. Lowe-Ardoin and unanimously adopted, the Board approved Chairman Tham to sign the updated contracts.

B. Professional Service Contracts, Legal Services for Fiscal Year Ended June 2015

1. Adams & Reese, LLP

The professional service contract for Adams & Reese, LLP for fiscal year July 1, 2014 through June 30, 2015, in the budgeted amount of \$15,000 was considered for Board approval.

2. The Derbes Law Firm, LLC

The professional service contract for the Derbes Law Firm, LLC for the fiscal year July 1, 2014 through June 30, 2015, in the budgeted amount of \$50,000 was considered for Board approval.

3. Shows, Cali, Berthelot, & Walsh, LLP

The professional service contract for Shows, Cali, Berthelot, & Walsh, LLP for the fiscal year July 1, 2014 through June 30, 2015, in the budgeted amount of \$10,000 was considered for Board approval.

Upon motion by Mr. Bruno, seconded by Mrs. Hutchinson and unanimously adopted, the Board approved Chairman Tham to sign the updated contracts.

C. Successful Exam Pass Letters

As part of an ongoing effort to review and update Board communications, Mrs. Saux presented a draft of a revised Successful Exam Pass Letter which consolidates two letters currently being sent. The Board reviewed the revised letter to be sent to every successful candidate who has passed all four parts.

Upon motion by Mr. Bruno, seconded by Mrs. Hutchinson and unanimously adopted, the Board approved the letter presented by Mrs. Saux.

D. Work Experience Verification

The Board's office reviewed an inquiry from NASBA regarding the Board's views on verification of a CPA's experience "by a husband for his wife that works within his CPA office."

The Board discussed and agreed it should review an applicant's verification on a case by case basis if the verification is from a relative of the CPA applicant.

E. Accountant versus Client Work Papers

R.S. §37:87 says a licensee shall furnish to a client or former client upon request and reasonable notice the following: a copy of the licensee's working papers that are records which would ordinarily constitute part of the client's records and are not otherwise available to the client.

The Board staff recently received an inquiry of what obligation a licensee has to share data files created by the licensee on Quickbooks. Several State Boards' policies were submitted for the Board's review.

The Board also discussed Board Rule §1705 Responsibilities to Clients.

As a professional courtesy, CPAs should work with each other and share work papers available. Electronic downloads of data should be provided if requested, even if the CPA created/input the data and especially if they charged the client for eventual work product/result. Reasonable fees can be assessed to provide and/or to convert records.
