#### I. CHAIRMAN'S REPORT

## A. Lisa A. Benefield – Deputy Director

Lisa A. Benefield was promoted from Compliance Investigator II to Deputy Director effective February 16, 2016.

#### B. Chase Bank

The Board is moving its operating account from Capital One to Chase Bank, largely to facilitate payroll direct deposit. The first direct deposit for Board staff occurred April 15, 2016 and the staff was very appreciative. Board members will receive a request for bank info in the next month so board compensation can be included in direct deposit.

#### C. State matters

1. Governor John Bel Edwards has issued several executive orders, one of which could directly affect our agency:

JBE 16-03 – This established a hiring and expenditure freeze. We have been advised by the Governor's Executive Counsel staff that a conservative reading would interpret the executive order applies to our agency unless we receive an exemption from the Commissioner of Administration. A request was submitted and we are awaiting a formal response.

Because this is an outstanding issue, the vacancy for the Compliance Investigator II position has not yet been posted with Civil Service.

2. Civil Service issued a General Circular Notice regarding a Proposal to Suspend Performance Adjustment authority for FY 16-17.

The Department of State Civil Service is recommending that the State Civil Service Commission suspend the authority to grant performance adjustments for one year, beginning June 29, 2016, for classified employees. A public hearing will be held on Wednesday, May 4, 2016 at 9 a.m. to consider adoption of this matter.

# D. Reminder - Financial Disclosure Statements - Due On or Before May 15, 2016

Board members were reminded that the "Tier 2.1 Personal Financial Disclosure Statement" must be filed with the State Ethics Board by each individual Board member on or before May 15, 2016. Additionally, members of Boards must file the disclosure form each year in which they hold office and by May 15 of the year following the termination of the holding of such office.

The regular and executive session minutes for the January 2016 Board Meeting were previously sent to Board members for review.

#### C. CPA Examination Fees

The Board's office received correspondence from the AICPA and NASBA regarding CPA examination fees. The correspondence was provided for the Board's review.

#### D. Next Version of Uniform CPA Examination

AICPA and NASBA provided information on the next version of the CPA exam and its administration. The new exam will launch April 1, 2017.

- ✓ Extension of testing window NASBA informs that each of the next four testing windows will be extended by 10 days, starting with the second quarter of 2016 (June 2016, September 2016, December 2016, and March 2017). The extension will be suspended for the June 2017 window, and reinstated for Q3 and Q4 of 2017 in order to mitigate scheduling issues due to score delays from the June 2017 window.
- ✓ **Score delay** Calibration of the new exam for scoring to ensure validity/accuracy will delay the release of June 2017 scores to 10 weeks (August 14, 2017) instead of the average 20-day score release.
- ✓ **Break** One 15-minute break will be offered to candidates during each section when test lengths increase to 4 hours for each. The break will not count as part of the 4 hour testing time.

- ✓ Combination of sections NASBA and AICPA determined that combinations of passing current sections and future sections will count toward completing the exam requirement.
- ✓ **Cost increase** REG and BEC will increase by one hour to 4 (same as AUD and FAR) with a corresponding increase from \$173.60 to \$193.45.
- ✓ **Review and appeal** Fees for score review will increase from \$150-\$200 to \$240 per section and score appeals will increase from \$500 to \$550 plus \$100 per challenged item.

It is expected that the Board will receive requests for extensions from candidates who are affected by the score delay next summer, as it may be difficult to schedule a section on or after August 14, 2017 by September 10, 2017. Some candidates may have already lost credits because of the inability to re-sit from July 1 – August 14, 2017 also.

Core Message Points provided by AICPA were provided for the Board's review.

# E. Exam Related Requests – Request for Extension of Exam credit for FAR

The Board was asked to reconsider a request previously presented at the January 2016 Board meeting based on new information.

The request was from a candidate who had credits for FAR (*expired 04/02/2016*), BEC (expires 11/28/2016), and REG (expires 02/26/2017). She had taken the remaining part, AUD, once in November and again in February 2016 without success. She plans to sit for the AUD section again in June.

Due to personal circumstances (moving out-of-town and becoming a significant caretaker of a terminally ill grandparent), the candidate requested that the Board extend the FAR credit.

The candidate's request and supporting documents were provided for the Board's review.

Upon motion by Mr. Bergeron, seconded by Mrs. Hutchinson, the Board unanimously approved an extension of the candidate's FAR exam credit until the expiration date of the BEC exam credit, November 28, 2016.

# F. Closure of Prometric Testing Site

The Board's office received information that the newest Prometric testing site opened in Lake Charles in April 2014 has closed February 26, 2016 due to termination by the landlord. Louisiana now has 4 testing sites:

- Alexandria
- Baton Rouge
- New Orleans
- Bossier City

# G. Renewal of Authorization for Candidates Lists prepared by NASBA

The Board considered an annual request from NASBA to release candidate lists (names, email addresses, and addresses) to interested parties. Upon motion by Mr. Bergeron, seconded by Mrs. Hutchinson and unanimously adopted, the Board approved the request from NASBA for the release of candidate lists.

# H. NASBA Experience Verification Service

The Executive Director shared that NASBA provided notice that it is launching a CPA Experience Verification Service aimed at providing accounting professionals worldwide with a reputable experience verification option for CPA licensure. It was created in response to the need for more coherent and standardized experience validation for international and domestic CPA licensure applicants.

The service is currently available in 10 jurisdictions (Illinois, Kentucky, Minnesota, Montana, Ohio, Oklahoma, Virginia, Washington, Washington, D.C., and Wisconsin), takes approximately 4-6 weeks, and the process includes an interview with a CPA with a comprehensive final report delivered to the Board of Accountancy in the end. The fee for international applicants is \$700; NASBA will provide more details on the domestic candidate service soon.

# E. Firm Name Change Requests for Board Consideration (2)

R.S. §37:83(G) says ... no firm holding a permit shall use a professional or firm name or designation that is misleading about the legal form of the firm or about the persons who are partners, officers, members, managers, or shareholders of the firm, or about any other matter. However, names of one or more former partners, members, managers, or shareholders may be included in the name of the firm or its successor.

Board regulation  $\S1707(D)(3)$  reads ... a CPA firm name is misleading within the meaning of R.S. 37:83.G if, among other things: ...(b) the CPA firm name includes the name of a person who is not a CPA.

Board regulation §1707(D)(4) reads ... A firm name not consisting of the names of one or more present or former partners, members, or shareholders may not be used by a CPA firm unless such name has been approved by the board as not being false or misleading.

The Board's office received two name change requests for out-of-state CPA firms registered with Louisiana moving to "network" firm or brand names. The Board staff requested guidance on the requests, as the Board has not adopted rules regarding network firm names, as provided in UAA Model Rule language 14-1.

#### 1. O'Connor Davies, LLP to <u>PKF</u> O'Connor Davies, LLP

This is a small NY firm with 29 equity partners licensed in NY and NJ. There is no ownership or structure change.

PKF International is a global network of accountancy firms. According to wikipedia, Pannell Kerr Forster was founded in 1969 when four accountancy firms from Australia, Canada, the UK, and the USA joined together to create an international association. Pannell is from William Henry Pannell's UK firm of Pannell Fitzpatrick & Co. founded in 1869. Kerr and Forster were from Errol Kerr and William Forster's USA firms in the early 1900s.

PKF is the common brand name to create an international accountancy brand – the name was shortened to PKF in 2000 and member firms are now adopting this name in their home markets or adding PKF as a prefix to the existing firm name.

The new letterhead PKF O'Connor Davies, LLP provided has a disclosure footnote that the firm is a member firm of the PKF International Limited network of legally independent firms.

### 2. McGladrey LLP to RSM US LLP

This is a large national firm whose principal place of business is Chicago, IL.

McGladrey was a founding member of RSM International, a network of global independent accounting, tax and consulting firms. RSM is admittedly a trade name. RSM was derived from initials of original founding member *firms* (Robson Rhodes (UK), Salustro Reydel (France) and McGladrey (USA)).

McGladrey advised it changed its name to compete internationally with the Big 4, Grant, and BDO, similarly situated global associations of accounting, tax and consulting firms, "fully consistent with trade name protocols deployed by their competitors."

It would seem that RSM US LLP is a single firm in the USA.

Currently, a similar firm permit registration with the Board is BDO US, LLP who changed from BDO Seidman, LLP in July 2010. The name change was presented to the board in April 2010 for consideration and approved. Appears BDO US, LLP is the U.S. member firm of BDO International – that is BDO US, LLP is a single firm in the USA.

Also registered with the Board is Grant Thornton, LLP from Missouri. Grant Thorton, LLP is the U.S. member firm of Grant Thornton International LTD, a network of independent firms. It appears that Grant Thornton, LLP is a single firm in the USA.

Upon motion by Mrs. Lowe-Ardoin, seconded by Mr. Bergeron and unanimously adopted, the Board approved the name change requests for the two out-of-state CPA firms registered with Louisiana.

The Board indicated that similar name change requests should continue to be brought to the Board for consideration.

# A. Review of CPE Report Forms for 2013-2015 Reporting Period

Enforcement Administrative Assistant Ashley Bolden performed a desk review of more than 7,000 CPE Report Forms. The forms were reviewed for completeness, correct number of

CPE hours, whether the correct ethics course was completed, and correct number of Accounting and Auditing hours (for those required).

# Findings included:

- 857 Number of CPE forms returned to date
  - 294 Description or Board approved Ethics missing
  - 226 Courses not categorized/unable to determine if limits met
  - 337 Incomplete form or other issues

# C. Failure to Submit CPE Reporting Forms

To date approximately 500 licensed CPAs had failed to submit their CPE Reporting forms for the 2013 – 2015 reporting period. Letters will be mailed to these licensees informing them that the Board's office had not received their completed CPE Reporting Form, and that the CPE form must be submitted to the Board's office within ten days or their License will be expired.

#### D. Audit of 2013 - 2015 CPE Report Forms

Board staff will begin the process of conducting a random sample audit of CPE reporting forms for the 2013 - 2015 reporting period once all known extensions and consent orders are finalized, and responses are received by those contacted for failure to submit CPE Report forms.

# E. Electronic Reporting of CPE

The Executive Director reported that the CPE module associated with CAVU was again demonstrated, but comments from staff are not positive. NASBA is upgrading its product for a Fall rollout and will be looked at again.

The Board reaffirmed its desire that all continuing education courses should be itemized annually by CPAs when renewing the CPA license; based on current noncompliance experience, reporting only the number of hours earned when renewing one's license without details doesn't seem likely to be complete.

- A. **Website** Proposal of up to \$9,000 received from Design the Planet including training (previously contracted in October 2010 for \$5,250)
  - Website needs to be made adaptable to smaller devices like smartphones and tablets
  - Security measures need to be updated; website is being hacked onto and other sites, including obscene sites, are being attached periodically
  - Website needs to be redesigned with more links and search features, and better streamlined text information
  - Analytical measures will be added (Google Analytics) to determine what pages are read, and how many people use the site
  - We want to be able to use plug-ins for a calendar (to reflect board meetings and reporting deadlines), YouTube videos, social media, and similar type features
  - Updating the website and making answers easier to find should help eliminate a lot of phone calls, freeing staff resources to focus on action items rather than answering common and often repetitive questions
- B. **Newsletter** NASBA offered to assist. Samples were distributed to Board members for their input and preferences on color/theme, etc. It was noted that articles would be needed and board members were asked to contribute ideas and writings as time goes on.

C. **Video** – NASBA has resources and offered to create short video on CPE rule changes.

#### XIII. REPORTS ON CONFERENCES / MEETINGS

A. Annual Conference for Executive Directors
March 15-17, 2016
Tucson, AZ

Mrs. Saux attended. Two major topics of concern were:

Promotion of CGMA designation by non-CPAs – A majority of state boards are opining that non-CPAs cannot use the title CGMA (chartered global management accountant) and be in compliance with state laws and regulations including the use of credentials/titles (as stipulated in discussion paper made available at 2015 NASBA Annual Meeting) – use of CGMA by non-CPAs is a violation if UAA Model language or similar as agreed to by both NASBA and AICPA is used, which our state board has in large part.

LAA R.S. §37:83(C) reads "No person shall use or assume the title "certified public accountant" or the abbreviation "CPA" or any other title, designation, words, letters, abbreviation, sign, card, or device tending to indicate that such person is a certified public accountant, unless the person holds a valid active certificate issued as provided for in this Part or a privilege pursuant to R.S. 37:94."

LAA R.S. §37:83(E) reads "No person or firm shall assume or use the title "public accountant", "certified accountant", "chartered accountant", "enrolled accountant", "licensed accountant", "registered accountant" or any other title or designation likely to be confused with the title "certified public accountant" or use any of the abbreviations "CA", "LA", "RA", "PA", or similar abbreviations likely to be confused with the abbreviation "CPA", unless such person or firm holds a valid active certificate or permit issued as provided for in this Part. The title "enrolled agent" or "EA" may only be used by individuals so designated by the Internal Revenue Service."

NASBA is performing a state-by-state analysis to be presented at its upcoming regional meetings titled "Preventing Consumer Confusion." Mrs. Saux asked for the Louisiana State Board's position on this. After much discussion, the Board reached the following conclusion at this time:

Louisiana State Board members do not see use of "CGMA" or "Certified Global Management Accountant" by a non-CPA as an issue at this time.

Regarding advertising membership in the AICPA, AICPA's agreement with NASBA provided that non-CPAs make it clear when referencing AICPA membership that they must use "non-CPA associate member of AICPA." Non-compliance of the AICPA provisions would make those persons subject to discipline by the AICPA ethics division.

Further, Board members do not find the designation "CGMA" or "Certified Global Management Accountant" to be confusing or misleading to the public. Nor does it find the use of "CGMA" by a non-CPA on its face to be in violation of the LAA R.S. §37:83(E) which reads, in part, "No person or firm shall assume or use the title "public accountant", "certified accountant", "chartered accountant", "enrolled accountant", "licensed accountant", "registered accountant" or any other title or designation likely to be confused with the title "certified public accountant" or use any of the abbreviations "CA", "LA", "RA", "PA", or similar abbreviations likely to be confused with the abbreviation "CPA", unless such person or firm holds a valid active certificate or permit issued as provided for in this Part."

Should the Louisiana State Board become aware of someone using CGMA in an adverse manner such as holding out as a CGMA firm, performing services as a CPA without being appropriately licensed, or advertising AICPA membership in a misleading manner inconsistent with the AICPA/NASBA agreement, it will investigate the matter.

Planned consolidation of Peer Review Administering Entities by the AICPA – Boards expressed concern about the lack of transparency / discussion with NASBA and member boards about proposal to reduce the number of AE from 41 to 8-10, the aggressive timeline of implementing change, and the potential cost increases to firms.
