The regular meeting of the State Board of Certified Public Accountants of Louisiana was called to order by Chairman Mr. Tham on Wednesday, August 1, 2012, in the offices of the Board at 601 Poydras Street, Suite 1770, New Orleans, Louisiana, 70130.

The purposes of the meeting were to review information and statistics concerning the CPA Examination, review information concerning expiration and reinstatement of Certificates, consider applications for certification, consider Firm Permit applications and related issues, consider executive session matters, and to transact any other business that required the Board's attention.

The meeting was called to order by Chairman Mr. Tham at 9:07 a.m. on Wednesday, August 1, 2012, upon motion by Mr. Harris, seconded by Mrs. Hutchinson and unanimously adopted.

I. CHAIRMAN'S REPORT

A. Staff Performance Adjustments (formerly called “merit increases”)

1. Changes by Civil Service

As reported at the April 2012 Board Meeting, merit increases are now referred to as performance adjustments. Under the new provisions, all classified employees' performance adjustments will be for the July 1st through June 30th period, with any increase to be granted or effective on October 1st of each year.

2. Performance Adjustments for Fiscal Year 2012 - 2013

The merit increases (performance adjustments) for state employees were suspended for the past two fiscal years, but performance adjustments are not suspended for the current fiscal year that began July 1, 2012. Mr. Henderson reported that it is anticipated that all classified Board employees will receive performance adjustments effective October 1, 2012. The percentage adjustment for classified personnel remains at 4%.

The Board determined that performance adjustments for the Board's unclassified personnel will also be effective October 1st each year.

B. Next Board Meeting at a University

Mr. Henderson reported that Board Member Mr. Bruno discussed the matter with local university officials and made preliminary arrangements for the Board to meet during the week of November 12-16, 2012. [Subsequently, the actual dates of the meeting were found to be more suitable for a meeting on the Dillard University campus instead of Xavier University which had been the location originally considered.]

C. Reminder - One Hour of Governmental Ethics Requirement for Public Servants

Board Members were reminded that all public servants, including all Board Members and staff, are required to receive one hour of education and training on the Louisiana Code of Governmental Ethics each year during their public employment or term of office. At the April 2012 Board Meeting the Board approved granting CPE credit for the ethics training for CPAs employed by state agencies or who may perform contractual services for the state, since it is employment related.

D. Sexual Harassment Training Requirement for Public Servants

The Board was informed that beginning January 1, 2013, each state agency is required to provide to each “public servant” of the agency a minimum of one hour of education and training on sexual harassment during each year of his or her public employment or term of office. The training must be completed by January 1, 2014.

It is expected that we will receive more information from the Department of Civil Service on the availability of training later this year or early next year. It may be useful for compliance purposes to consider if the training could be incorporated in a meeting's agenda or perhaps coincide with a Board meeting date.

II. APPROVAL OF MINUTES

The regular and executive session minutes for the April 2012 Board Meeting were previously sent to Board members for review.

By motion of Mr. Bergeron, seconded by Mrs. Honoré Thomas and unanimously adopted, the Board approved the April 2012 regular and executive session minutes as drafted.

C. Exam Eligibility Requirement for CPA Examination

At the April 2012 Board Meeting the Board approved a request from this exam candidate that she be allowed to sit for the CPA examination as a Louisiana candidate. The candidate resided in Louisiana since June of 2010, but had an H-4 visa and is not considered a permanent resident of the United States. Subsequently, the Board’s office was informed that the Foreign Academics Credentials Service had considered the candidate’s UK Chartered Accountant status and combined this credential with her formal university education. It appears that the evaluation deemed the candidate’s credential as equivalent to 63 semester hours.

After discussion, upon motion by Mrs. Honoré Thomas, seconded by Mrs. Hutchinson and unanimously adopted, the Board determined that the candidate is not approved to sit for the Louisiana CPA examination, since she does not meet the educational and degree requirements. The Board also directed Mr. Henderson to inform Foreign Academics Credentials Service of the determination.

D. Request for Acceptance of 1.5 hour Cost and 1.5 Tax Courses at Indiana University

A CPA exam candidate, inquired as to whether the Board would accept accounting courses that Finance majors take at Indiana University.

After discussion, upon motion by Mrs. Hutchinson, seconded by Mr. Bergeron and unanimously adopted, the Board determined that the course could be used as a 3 hour elective, but could not be used to fulfill the accounting courses requirements.

IX. RECURRING MATTERS AND DEFERRED ITEMS

A. Update on Request from Delgado Community College for Acceptance of Courses for Educational Requirements for the CPA Examination

The Board had deferred action on the request from the April 2012 Board Meeting, pending receipt of comments from the LCPA Accounting Education Issues Committee. Mr. Henderson reported that this LCPA Committee will meet in the Fall, and that he will discuss the matter with the educators at that time and report back to the Board.

B. NASBA Items

1. NASBA International Evaluation Services (NIES)

The Board reviewed an e-mail from NASBA International Evaluation Services (NIES) Manager Brentni Henderson-King, requesting information as to how the Board prefers communication between NIES and international education evaluation companies.

2. Other NASBA Items

Mr. Harris, Chairman of NASBA, reported on other NASBA topics and items of interest.

C. Society of Louisiana CPAs (LCPA)

Ronald Gitz, LCPA Executive Director, discussed matters of interest to the Board and the profession including issues related to the Deepwater Horizon (BP) settlement.

X. CPE ITEMS

A. Reporting of CPE Electronically

Mr. Henderson reported on the status of CPE being reported electronically to the Board's office.

B. Revision of Board Rules Regarding CPE

At the April 2012 Board Meeting the Board reviewed recommendations of changes to Board rules governing CPE by the CPE Rules Committee. The Board made some changes to the proposed revisions by the Rules Committee, but directed that action be deferred until next year because some of the changes, e.g., rounding of hours and half-hour increments could complicate reporting for the current CPE cycle.

C. CPE Informational Bulletin

Mr. Henderson reported that the Board's office usually mails a CPE Informational Bulletin to all licensees in August or September of the year that CPE is to be reported.

The Board reviewed a draft of the CPE Informational Bulletin prepared by Board staff. Upon motion by Mr. Harris, seconded by Mrs. Hutchinson and unanimously adopted, the Board approved the bulletin as drafted.

D. Request for Approval of CPE for Publication

Timothy G. Burns, CPA submitted a request to obtain CPE credit for publication of "Accounting Whiz Kid", which is designed to instruct college students studying accounting.

Upon motion by Mr. Harris, seconded by Mr. Bergeron and unanimously adopted, the Board approved 30 hours of CPE in the area of personal development.

E. Request for Approval of CPE for Certification Exams

Marco Bodellini, CPA submitted a request for approval of CPE for completion of four (4) separate certification exams. Mr. Bodellini requested 17.5 CPE credits for each exam.

1. Certified Anti-Money Laundering Specialist (CAMS) Designation
2. Certified Treasury Professional (CTP) Designation
3. Certified Governmental Auditing Professional (CGAP) Designation
4. Certified Specialist in Asset Recovery (CSAR) Designation

Upon motion by Mr. Bergeron, seconded by Mr. Harris and unanimously adopted, the Board approved Mr. Bodellini's request.

F. Ethics Courses for 2013 - 2015 CPE Reporting Period

At the April 2012 Board Meeting the Board determined that each sponsor who duly submitted a course synopsis and questionnaire should be advised to submit a complete proposed course for further review by mid-July. The Board also decided that Board staff would complete a review of the updates of seven (7) currently existing Board-approved ethics courses, and that Board Members could review the potential five (5) new courses. A different Board Member could be assigned to review a course and a single Board

Member could serve as the “gate keeper” for a final review of all courses. Board staff was asked to develop review checklist to assist in the process.

Shortly after the April meeting, the sponsors were contacted and asked to submit drafts of their proposed courses by July 13. Four (4) newly proposed ethics courses were submitted timely by the new sponsors; these have been previewed by Board staff.

1. Updates of Currently Existing Board-approved Ethics Courses

Mr. Henderson reported that Board staff completed some reviews and checklists for existing Board-approved ethics courses.

The Board deferred approval until the next Board meeting.
