I. CHAIRMAN'S REPORT

A. Navigating Your Way To Becoming a CPA

The firm wishes to keep the legal entity name, especially to be used for attest services, and wishes to use its dba name for letterhead, newsletters, etc.

The Board discussed with input from Mr. Neyrey, Managing Partner, and offered solutions acceptable to Mr. Neyrey. The Board did not allow the use of a "dba."

IX. RECURRING MATTERS AND DEFERRED ITEMS

**A. Delgado Community College -
Acceptance of Courses for Educational Requirements for the CPA Exam *****

At the November 2012 Board Meeting the Board deferred action on this matter until a later Board Meeting. Executive Director Mrs. Saux and LCPA Executive Director Mr. Gitz were to discuss the matter further.

B. Report on NASBA Items

1. Recommendations for Vice Chair for 2014-15 Year

The Board's office received several e-mails asking for support for the candidacy as Vice Chair of NASBA for the 2014-15 year on behalf of three individuals: Janice Gray (Oklahoma), Kenneth R. Odom (Alabama), and Ted Long (Ohio).

The Board had previously considered that it would not send letters of support for NASBA candidates given that Mr. Harris and Mr. Tham both served on the NASBA Nominating Committee and will review all candidates impartially. Mr. Tham is still a member of that committee until October 31, 2015.

At the November 2012 Board Meeting, the Board directed that this matter be included on the Board’s future meeting agendas in order that progress can be tracked to ensure electronic reporting in the future.

B. CPE Rules Committee - Revision of Board Rules Regarding CPE

The Board’s CPE Rules Committee (Mr. Bruno, Mrs. Honore Thomas, and Mrs. Hutchinson) will schedule a conference call in order to resume the Committee’s work.

C. Audit of 2010 - 2012 CPE Reporting Forms

The Board reviewed information presented by Compliance Investigator Carolyn Wainright regarding the audit of CPE reporting forms for the 2010 – 2012 reporting period. A total of 175 CPE Forms were randomly selected for audit.

As of January 23, 2014, 137 of the 175 had been reviewed, with the following results:

- 66 had no deficiencies or problems.
- 39 had some invalid documentation, but still had sufficient number of hours.
- 31 have insufficient hours due to invalid documentation.
