Minutes

I. CHAIR'S REPORT

A. Personnel

1. Janet Volion, the Board's Accounting Technician, submitted her resignation on March 13, 2019. She accepted a similar position with the Port of New Orleans and her last day with the Board was April 12, 2019.

The Accounting Technician position was posted with Civil Service from March 15 - 31, 2019. Sixteen applications were received and four applicants were interviewed in early April. An offer was made and accepted by Jennifer Austin of Meraux, Louisiana. Her first day of employment will be May 6, 2019.

- 2. John Morgan, the Board's new Compliance Investigator, began employment with the Board on February 11, 2019.
- 3. Karen Watts, a temporary employee with Westaff, worked through February of 2019, helping primarily with entering and filing 2018 CPE reporting forms.

B. Reminder - Financial Disclosure Statements - Due On or Before May 15, 2019

Board members were reminded that the "Tier 2.1 Personal Financial Disclosure Statement" must be filed with the State Ethics Board by each individual Board member on or before May 15, 2019.

Additionally, members of Boards must file the disclosure form each year in which they hold office and by May 15 of the year *following the termination of the holding of such office*.

C. Reminder – Governmental Ethics Requirement for Public Servants

All Board Members (and staff) are required to complete one hour of education and training on the Louisiana Code of Governmental Ethics for 2019. This is an annual requirement. The course must be completed prior to December 31, 2019.

D. Reminder – One Hour of Sexual Harassment Training Requirement for Public Servants

All Board Members (and staff) are required to complete a minimum of one hour of education and training on sexual harassment no later than December 31, 2019. This is an annual requirement. The course is available through the Department of Civil Service.

Additionally, Act 270 of the 2018 Legislative Session requires one (1) additional hour of training for Supervisors. This training is provided by Civil Service through the Comprehensive Public Training Program (CPTP).

D. Elijah Watt Sells Award for 2018

For the third year in a row, the Board was contacted by NASBA for permission to release contact information on a CPA exam candidate to the American Institute of CPAs (AICPA) because a Louisiana candidate had been chosen to receive the Elijah Watt Sells Award for 2018. The annual award program was established by AICPA in 1923 to recognize outstanding performance on the Uniform CPA Examination and is given to CPA candidates that have passed the examination with a cumulative average score above 95.5 across all four sections of the CPA exam and have passed all four sections on their first attempt.

As authorized at the April 2017 board meeting, the Executive Director, after consultation with the Board chair, approved release of the contact information as requested in February 2019 for the purpose of recognizing the candidate's achievement.

The AICPA issued a press release on April 11, 2019 announcing the winners of the 2018 Elijah Watt Sells Award. The Board congratulated Anthony Salazer of

Louisiana for being awarded the Elijah Watt Sells Award for 2018. On behalf of the Board, the Chair will send a letter of congratulations.

A. Society of Louisiana CPAs (LCPA)

Ron Gitz, LCPA CEO/Executive Director, reported on items of interest to the profession.

B. Meal Reimbursement Request

The Division of Administration approved the Board's November 2018 request for meal reimbursement, to board members and staff when dining with board members, of up to the amount specified in the Louisiana Administration Code section (LAC 52:I.1703) used by the Board of Ethics for meal reimbursements excluding alcohol and related tax and tip. The current amount is \$61, and is reviewed and updated annually in July, rounded to the nearest whole dollar, when the Consumer Price Index moves up sufficiently.

The Board will need to make this request annually to the Division of Administration, regardless of whether the amount in the Louisiana Administration Code changes or not.

By motion of Mr. Hazel, seconded by Mr. Bergeron and unanimously adopted, the Board authorized the Executive Director to request annual approval every July by the Division of Administration for meal reimbursement, to board members and staff when dining with board members, up to the amount specified in LAC 52:I.1703. Mrs. Lowe-Ardoin was absent.

F. Request to Waive 2018 CPE due to Medical/Personal Issues

Mr. Louis Lee, CPA, Certificate No. 24103, submitted a request to the Board to consider waiving his 20 hours of CPE for the 2018 Reporting period due to personal and health issues and health-related issues of his daughter.

Mr. Lee's request and medical documentation were provided for the Board's review.

The matter was deferred by the Board until the July 2019 meeting to obtain additional information in order to make a determination.

G. Request for Extension to Complete 2018 CPE due to Medical Issue

Mr. Paul Bryan Duncan, CPA, Certificate No. 23015, submitted a request to the Board asking for additional time past March 31, 2019 to complete his 2018 CPE due to surgery in 2018.

The written request and medical documentation were provided for the Board's review.

Upon motion by Mr. Hazel, seconded by Mrs. Honoré Thomas the Board approved Mr. Duncan's request for an extension of his 2018 CPE requirements to April 30, 2019 with a Consent Order. Mrs. Lowe-Ardoin was absent.

H. Request for Texas Ethics Course to Satisfy 2018 Ethics Requirement

Mr. Mark Worthen, CPA, Louisiana Certificate No. 24041, lives and works in Texas and is a licensed CPA in both Louisiana and Texas. He submitted a request asking the Board to consider allowing his Texas Ethics course taken in February 2019 to count as timely taken in place of the Louisiana Ethics course that was required for 2018, without requiring a Consent Order or fine.

His written request and documentation were provided for the Board's review.

Upon motion by Mrs. Honoré Thomas, seconded by Mr. Bergeron the Board approved Mr. Worthen's request to use his Texas Ethics course completed in February of 2019 to satisfy his 2018 Louisiana Ethics requirement without requiring a Consent Order or fine, and denied the request to waive his reinstatement fee to renew his license for 2019. Mrs. Lowe-Ardoin was absent.

I. Professional Ethics Update

Mr. Hazel advised that the Ethics Committee recommended 3 hours of Professional Ethics for the year 2020 be required by all actively licensed CPAs in order to renew their Louisiana license for 2021. The Committee also suggested that interested vendors prepare and offer a second course (or an alternative course) tailored to industry CPAs which focuses less on independence issues and more on scenarios found in private practice.

Upon motion by Mr. Hazel, seconded by Mrs. Honoré Thomas the Board adopted the Ethics Committee recommendations that there will be a required Board – Approved Professional Ethics course of 3 hours to be completed in calendar year 2020. Mrs. Lowe-Ardoin was absent.

J. NASBA cpeauditservice

Ms. Saux reported that NASBA has rolled out its new CPE Tracking Service and transferred the 8 boards currently using the older version.

NASBA is looking for a commitment to start Louisiana as soon as September. Data is pulled from ALD to create accounts. NASBA has pledged to work with societies to provide electronic transfers for states that sign on.

There is no charge from NASBA. It will facilitate electronic reporting and assist CPAs with CPE tracking.

Staff would like to move forward with this – with voluntary participation of CPAs in 2019 and mandatory participation of CPAs effective 1/1/2020.

Pros – electronic entry and document upload/retention; CPA can see where they are at all times and compliance with Louisiana requirements; CPAs know when "sent"; board can better monitor compliance and audit quicker.

Cons – CPAs have another account and password; learning curve.

The Board agreed to utilize NASBA's service and had some questions for NASBA which staff will follow-up.

A. Renewal of Contracts for Current PROC Members

Contracts for the PROC members for fiscal year July 1, 2019 – June 30, 2020 were prepared and ready for the PROC members' signature. The contracts are for \$150 per hour with a maximum of \$6,000.

The Board considered whether to offer the contracts to the current PROC members, Mr. George Lewis, Mr. J. Charles Parker II, and Mr. Lonnie Stockwell for the July 1, 2019 – June 30, 2020 fiscal year. All three previously expressed interest in continuing for another year.

Upon motion by Mr. Bergeron, seconded by Mrs. Honoré Thomas, the Board approved the contracts for the current PROC members for the fiscal year 2019 – 2020.

B. Legislative Bills

Ms. Saux reported that there were several bills in varying stages that board staff were following in the Regular Legislative Session for 2019 that will end in June.

Additionally, there were open items from last year's session, Act 655, Act 454 & rule making, which are being addressed.

Act 655 requires all Boards and Commissions that issue licenses, permits or certificates to include information on how to file complaints about actions or procedures of the Board on its website and in all correspondence addressed to any applicant or licensee. Ms. Saux will ensure Board compliance relative to the Act, and has added the following language, when appropriate, to Board correspondence:

In compliance with Act 655 of the 2018 Louisiana Regular Legislative Session, the Board gives notice to its licensees and applicants of their opportunity to file a complaint about actions or procedures of the board to one or more of the following organizations: The State Board of Certified Public Accountants of Louisiana, 601 Poydras Street, Suite 1770, New Orleans, LA 70130; (504) 566-1244; sitemaster a cpaboard state laws; the Committee on House & Governmental Affairs, Louisiana House of Representatives, P.O. Box 44486, Baton Rouge, LA 70804; (225) 342-2403; hagailegis lagov; and/or the Committee on Senate & Government Affairs, Louisiana Senate, P.O. Box 94183, Baton Rouge, LA 70804; (225) 342-9845; sagalegis lagov.

Act 454 requires the Board to conduct a Public Hearing; therefore, the Board set the date of the Public Hearing to Monday, July 15, 2019 at 9:00 a.m. Ms. Saux presented a draft notice and will have it published in the Louisiana Register as required.

Ms. Saux also reported that the Board will need to consider a rule change, which could take 9-12 months, regarding continuing testing. All proposed rule changes need to be submitted to the Occupational Licensing Review Commission (OLRC) before publication of the Notice of Intent (NOI) in the *Louisiana Register* and re-submitted before final publication. NASBA's Board of Directors approved continuous testing on the CPA Exam and expects nationwide approval by June 30, 2020.
