The meeting was called to order by Chair Mrs. Hutchinson at 9:07 a.m. on Thursday, July 23, 2020, upon motion by Mrs. Honoré Thomas, seconded by Mr. Langley and unanimously adopted.

I. CHAIR'S REPORT

A. Legal Counsel

The Legal Services Contracts for the Derbes Law Firm and Adams and Reese, LLP were approved by the state on June 9, 2020 and the Legal Services Contract for Shows, Cali & Walsh, LLP was approved by the state on June 23, 2020. The three contracts are for three fiscal years and are effective July 1, 2020 through June 30, 2023.

B. PROC Contracts

George Adair Lewis, John Charles Parker and Leon L. Stockwell have all entered into another 12-month PROC contract with the Board, effective July 1, 2020 through June 30, 2021.

C. Personnel

Carolyn Wainright, the Board's Compliance Investigator, is retiring from state service effective September 30, 2020.

D. COVID-19 Updates

The Board's Office staff continues to stagger schedules and/or work from home to not have more than 50% of the staff in the office at once due to the City of New Orleans' Phase Two guidelines.

E. Market Pay Adjustments effective July 15, 2020

All classified employees who were actively employed six months prior to July 15, 2020 received a market adjustment effective July 15, 2020 ranging from 2-4%.

F. Performance Evaluations for Fiscal Year 2019 – 2020

Performance evaluations, normally due August 31, 2020, have been extended to October 31, 2020 for all classified employees that were employed with the Board at June 30, 2020 and will be completed prior to October 31, 2020.

G. Performance Planning for Fiscal Year 2020 - 2021

All Board classified employees will receive Performance Planning (performance expectations) for fiscal year 2020 - 2021 no later than October 31, 2020, in accordance with Civil Service rules.

H. Reminder - One Hour of Governmental Ethics Requirement for Public Servants

All Board Members and staff are required to complete one hour of education and training on the Louisiana Code of Governmental Ethics for 2020. This is an annual requirement. All Board Members and staff must complete the course prior to December 31, 2020.

I. Reminder - One Hour of Sexual Harassment Training Requirement for Public Servants

All Board Members and staff must complete a minimum of one hour of education and training on sexual harassment no later than December 31, 2020. Additionally, Act 270 of the 2018 Legislative Session requires one (1) additional hour of training for supervisors and/or those who are designated to accept complaints of sexual harassment in an agency. The courses are available through the Department of Civil Service.

II. APPROVAL OF MINUTES

The regular minutes for the April 2020 Board Meeting were previously sent to Board members for review. Due to the COVID-19 pandemic, there was no executive session held in April 2020.

By motion of Mr. Langley, seconded by Mrs. Alizadeh and unanimously adopted, the Board approved the April 2020 regular session minutes as drafted.

III. TREASURER'S REPORT

- A. Financial statements for the periods ended March 31, 2020 and May 31, 2020 were presented for the Board's review.
- B. Financial statements for the period ended June 30, 2020 were not available as additional year-end entries were incomplete, and actuarial information from OSRAP for pension and OPEB related entries had just recently been received.

C. CPA Examination Fees

The Board's office received correspondence from the AICPA and NASBA regarding CPA examination fees. Although AICPA and NASBA both communicated last year that a fee change was not anticipated for 2020 or 2021, Prometric's hourly and security fees were increased. However, AICPA and NASBA have advised that due to increased technology and other costs and unanticipated declining candidate volumes, increases in fees were necessary. Beginning January 1, 2021, AICPA's section fee will increase from \$100 to \$110 and NASBA's section fee will increase from \$20 to \$25. For Louisiana candidates, this increase became effective July 4, 2020 because Louisiana provides a 9-month NTS.

The correspondence was provided for the Board's review.

Separately, an agreement to continue using NASBA's CPA Exam Services (CPAES) for Louisiana candidates (in place since 2007) included an increase effective August 1, 2020 in examination application processing from \$150 to \$160 for the initial application and an increase for re-exam candidates from \$75 to \$80 for each section application. The last increase had been in July 2014. Pre-exam advisory services (primarily a review of transcripts to ascertain whether a candidate meets our education requirements) were increased from \$100 to \$125. The Board currently performs those services free-of-charge upon request, although Board Rules allow the board to assess a fee not to exceed \$100 and Statutes allow up to \$200 for that service.

D. NTS and Exam Credit Extensions due to Testing Center closures

On March 17, 2020 Prometric Testing Centers issued notice that all U.S. testing centers would be closed for 30 days effective immediately due to the COVID-19 pandemic. They later extended the closures thru April 30th and slowly opened as state and local jurisdictions have allowed.

At its April 2020 board meeting, the Board approved NTS extensions as recommended by NASBA.

As the Prometric Testing Center closures were extended, NASBA's recommendations for NTS and exam credit extensions were modified to the following:

(1) NTS extensions – It was recommended that all candidates with NTS expirations between April 1 – December 30, 2020 be extended until December 31, 2020. If approved, NASBA could do that for all jurisdictions without any further action from boards.

(2) Credit Extensions – It was recommended that all candidates with credit expiring between April 1- December 30, 2020 be extended until December 31, 2020. If approved, NASBA could do that for all jurisdictions without any further action from boards.

NASBA offered to communicate to all candidates on behalf of boards how these issues were being handled and requested guidance and authorization/approval from all boards.

After input from the board members, the Executive Director advised NASBA that Louisiana's board determined it would adopt the recommendations from NASBA.

Upon motion by Mr. Langley, seconded by Mrs. Alizadeh, the Board ratified its determination to approve NTS extensions to December 31, 2020 for all candidates with NTS expirations between April 1 – December 30, 2020.

Upon motion by Mr. Langley, seconded by Mrs. Alizadeh, the Board ratified its determination to approve credit extensions to December 31, 2020 for all candidates with expiring exam credits between April 1 – December 30, 2020.

X. RECURRING MATTERS AND DEFERRED ITEMS

A. Society of Louisiana CPAs (LCPA)

Ronald Gitz, LCPA CEO/Executive Director, reported on the following items:

- 1. Legislative items
- 2. Other items of interest

B. Legislative Update

The Executive Director advised that the 2020 Regular Session was halted in mid-March and resumed in early May, and ended on June 1st. There was also a Special Session held in June. The outcome was that some of the legislative bills under consideration that would affect our Board were tabled. Several new bills were filed in response to COVID-19.

Among legislative items reported on, the executive director reported that HCR 71 was adopted June 1, 2020 and directs licensing agencies to suspend license renewal fees imposed on businesses based in Louisiana due from July 1, 2020 thru June 30, 2021. It only applied to those estimated to have one and a half years of reserve funds available. LAA contacted us and ultimately issued an Informational Report which listed our board and 18 other qualifying licensing boards, of which only 7 impose license renewal fees on Louisiana businesses. It is estimated that this would reduce our budgeted renewal fee revenue for the 2020-21 fiscal year by \$65,000, not including delinquent or reinstatement fees. Further, our software does not currently distinguish between Louisiana and non-Louisiana businesses, so there could be some configuration costs involved to implement this. The Informational Report was presented for the Board's review.

Upon motion by Mrs. Alizadeh, seconded by Mr. Langley and unanimously adopted, the Board waived Firm Permit renewal fees for all businesses, regardless of where based, through June of 2021, including delinquent fees.

C. COVID-19 - Request for Board Review and Consideration of Extensions of Due Dates for CPE and Peer Reviews

At the Board's April 2020 board meeting, the Board deferred two questions received from the public regarding CPE and Peer Review until the July meeting.

1. Regarding CPE – Question #1: Will the State Board provide some type of CPE relief or waivers to CPAs for the 2020 year? What type of CPE relief can the State Board offer to Louisiana CPAs for the year 2020?

The following was provided on Boards of Accountancy (BOA) action, to date, on CPE extensions due to COVID-19:

• Waiver: 0

• Self-Study Restrictions Lifted: 4

Extensions: 8No Changes: 43

7 of 8 BOAs that have adopted extensions had due dates of June 30th and extended the due date to earn CPE anywhere from 60 days to 180 days.

After review and discussion, the Board made no changes to Louisiana's CPE due date of December 31, 2020 nor granted automatic waivers for the 2020 year, but would continue to monitor the situation.

2. Regarding Peer Review - Question #2: Would the State Board waive or extend peer review requirements by 6 months for CPAs affected by the virus uncertainty?

This issue was addressed nationally by the AICPA Peer Review Board (PRB) at its open session on May 7, 2020. It voted to grant a six-month automatic extension to firms with reviews, corrective actions or implementation plans with original due dates falling between January 1 – September 30, 2020. Further, the PRB indicated it would continue to monitor the impacts of COVID-19 through the summer months and evaluate whether automatic extensions would be appropriate for firms with due dates after September 30, 2020. There was concern that firms would wait until the extended due date and are to be encouraged to have their reviews performed as soon as they are able.

The action taken by AICPA's PRB answered the inquiry, and the Board made no additional change.

The correspondence also included instructions for reinstatement after June 2, 2020. To date, none of the seven individuals below have provided the 2019 CPE Report to reinstate their Certificate to an Active status.

D. Audit of 2019 CPE Reported

It was reported that CPE Coordinator, Ramzey Bunley, was conducting an audit of CPE Report Forms for the 2019 reporting period. A total of 100 CPE Forms were randomly selected for audit. Ms. Bunley mailed notification to all CPAs on July 10, 2020 with a return date of August 7, 2020 to submit all required documentation.

XII. NEW MATTERS

A. NASBA Releases Proposed Revisions to UAA Model Rules

The Board received notice that NASBA released proposed revisions to the UAA Model Rules which were developed by the AICPA/NASBA CPA Evolution Initiative. A copy was provided for the board's review and discussion. Comments were requested by August 31, 2020.

B. AICPA Exposure Draft – Proposed revised interpretation on Records Requests

The Board adopted the AICPA Code of Professional Conduct when it revised its rules in October 2017 (Chapter 17, §1700.A.5). For the board's review was a proposed revision by AICPA on Records Requests, which is a common inquiry to the Board and staff. Comments were requested by September 30, 2020.

C. Changes to State Travel for New Fiscal Year

The State made some revisions to its Travel Regulations, which the Board is required to follow unless specifically exempted.

Notably, at December 31, 2020, Short's Travel will no longer be the State's mandatory travel agency and instead, effective January 1, 2021, Christopherson Business Travel will be the new agency. Also, the mileage reimbursement rate was changed from \$0.575 to \$0.57 per mile for use of personal vehicle for in-state travel by board members. Finally, the only reimbursable airport parking at the New Orleans International Airport will be USPARK's uncovered parking lot.

Remote testing is being explored as a delivery alternative to a lockdown of test centers. State Board executive directors participated in a Zoom video call with NASBA, AICPA, and Prometric representatives on June 23, 2020.
