The meeting was called to order by Chair Mrs. Hutchinson at 1:25 p.m. on Wednesday, April 28, 2021, upon motion by Mrs. Lowe-Ardoin, seconded by Mr. Langley and unanimously adopted.

Upon motion by Mr. Hazel, seconded by Mrs. Lowe-Ardoin, the Board went into executive session at 1:25 p.m. Upon motion by Mr. Langley, seconded by Mrs. Lowe-Ardoin, the executive session adjourned at 3:47 p.m. Upon motion by Mr. Hazel, seconded by Mrs. Lowe-Ardoin, the Board went back into Executive Session at 3:55pm. Upon motion by Mr. Hazel, seconded by Mrs. Lowe-Ardoin, the executive session adjourned at 4:24 p.m.

The meeting was called to order by Chair Mrs. Hutchinson at 9:02 a.m. on Thursday, April 29, 2021, upon motion by Mr. Bergeron, seconded by Mrs. Alizadeh and unanimously adopted.

Upon motion to deviate from the agenda by Mr. Bergeron, seconded by Mrs. Alizadeh, the Board took up the Executive Session items, specifically the recording of the Board Hearing decision, prior to the Chair's Report.

I. CHAIR'S REPORT

A. Darla M. Saux, CPA - Official Retirement Date/Position Change

Ms. Saux retired as the Board's Executive Director effective April 1, 2021. A request for Unclassified Authority was submitted to the Department of Civil Service for a temporary unclassified position. This position would allow Ms. Saux to serve part-time as a rehired retiree, in a consulting capacity, to assist with the transition of the new Executive Director. The position was approved by Civil Service and is valid through April 5, 2022.

B. Lisa A. Benefield, Esq. – New Executive Director

Lisa A. Benefield was hired as the new Executive Director by the Board's Executive Director Search Committee. The official start date as Executive Director was April 2, 2021.

C. Resolutions – New Executive Director

1. Authorization for Executive Director Responsibilities and Duties

The Board was asked to consider the following resolution to designate Lisa A. Benefield as the appointing authority for the agency's classified staff positions; official custodian of the agency's records; State Ethics Board liaison; signatory authority along with the Board members on the operating bank account used for payroll checks and operating disbursements retroactive to Ms. Benefield's official start date of April 2, 2021.

"BE IT RESOLVED: Lisa A. Benefield is designated appointing authority for the agency's classified staff positions; official custodian of the agency's

records; State Ethics Board liaison; signatory authority along with the Board members on the operating bank account used for payroll checks and operating disbursements effective April 2, 2021."

By motion of Mr. Langley, seconded by Mrs. Lowe-Ardoin, the Board ratified the above resolution.

2. Resolution for Iberia Bank Maintenance Form

A separate resolution was required to designate Ms. Benefield as the Administrator who may set up users for online access under the terms of the Iberia PLUS Banking Business services available for the Board's checking account.

"BE IT RESOLVED: Lisa A. Benefield is designated by the Board as Administrator who may set up users for online account access under the terms of the Iberia PLUS Banking Business services available for the Board's checking account. The Board Chair and Secretary, as authorized signers on this bank account, are hereby authorized to execute the Iberia Bank Maintenance Form necessary to add Lisa A. Benefield and to remove the current name, Darla M. Saux, as Administrator.

By motion of Mr. Bergeron, seconded by Mr. Langley, the Board unanimously adopted the above resolution.

D. Deputy Director Position

Due to Ms. Benefield's hire as Executive Director, the Board's Deputy Director position was posted with the Louisiana Department of State Civil Service and Indeed.com from January 27 - February 10, 2021 to fill the open position. 63 applications were received. Ms. Saux and Ms. Benefield conducted interviews in March of 2021. Caren Singleton, the Board's Licensing Analyst, was hired as the new Deputy Director effective April 5, 2021.

E. Licensing Analyst I

Due to Ms. Singleton's hire as Deputy Director, the Licensing Analyst I position became vacant. The position was posted with the Louisiana Department of State Civil Service for three weeks in April, ending April 28, 2021. Interviews were expected to begin in early May 2021.

F. Westaff

Minutes

As previously reported, Elrayel Williams, a temporary employee with Westaff, began working in the Board office on December 16, 2020. However, she accepted a full-time position, so her last day was February 1, 2021.

G. Reminder - Financial Disclosure Statements - Due On or Before May 15, 2021

Board Members were reminded that the "Tier 2.1 Personal Financial Disclosure Statement" must be filed with the State Ethics Board by each individual Board member on or before May 15, 2021.

Members of Boards must file the disclosure form each year in which they hold office and by May 15 of the year following the termination of the holding of such office.

H. Reminder - Governmental Ethics Requirement for Public Servants

All Board Members (and staff) were reminded to complete one hour of education and training on the Louisiana Code of Governmental Ethics for 2021. This is an annual requirement. The course must be completed prior to December 31, 2021.

I. Reminder – One Hour of Sexual Harassment Training Requirement for Public Servants

All Board Members (and staff) were reminded to complete a minimum of one hour of education and training on sexual harassment no later than December 31, 2021. This is an annual requirement. The course is available through the Department of Civil Service.

Additionally, Act 270 of the 2018 Legislative Session requires one (1) additional hour of training for Supervisors. This training is provided by Civil Service through the Comprehensive Public Training Program (CPTP).

J. COVID-19 Update

Governor Edwards lifted the statewide mask mandate effective April 28, 2021 with some exceptions including schools, nursing homes, hospitals and some state buildings.

The Mayor's office was expected to announce changes for Orleans Parish based on the new guidance from the CDC.

II. APPROVAL OF MINUTES

The regular and executive session minutes for the January 2021 Board Meeting were previously sent to Board members for review.

By motion of Mr. Bergeron, seconded by Mrs. Alizadeh, and unanimously adopted, the Board approved the January 2021 regular and executive session minutes as drafted.

B. 2021 CPE Reminder Email

An email blast was sent Wednesday, March 24, 2021 to 7,297 CPAs as notice that the 2021 CPE Report Form was available on the Board's website. The email included a reminder to complete 2020 CPE for those who had not yet reported their CPE to the Board. Reminder emails specifically to CPAs who had not yet reported their CPE to the Board was anticipated to go out in early May 2021.

C. Professional Ethics Update

The Ethics Committee recommended a 3-hour Professional Ethics requirement for the year 2022 for all actively licensed CPAs in order to renew their Louisiana license for 2023.

^{*116} total CPE forms were returned to CPAs. 76 of 116 forms have been accepted on the 2nd attempt. 40 of 116 forms have not been resubmitted.

CPE Coordinator, Ramzey Bunley, communicated via email with the 2020 CPE Ethics vendors and requested a list of 2020 participants thus far and course evaluations no later than May 21, 2021. The vendors were informed of the CPE extension to June 30, 2021 with a request to keep the course open and available through December 31, 2021. Additionally, they were informed of the Board's Professional Ethics requirement for calendar year 2022 and were asked to express their interest.

Once received, the evaluations are expected to be provided to the Ethics Committee members (Letti Lowe-Ardoin, Sue S. Alizadeh, Grady Hazel) via Smartsheet.

XI. NEW MATTERS

A. Renewal of Contracts for Current PROC Members

Contracts for the PROC members for fiscal year July 1, 2021 – June 30, 2022 were prepared and ready for the PROC members' signature. The contracts are for \$150 per hour with a maximum of \$6,000.

The Board considered whether to offer the contracts to the current PROC members, Mr. George Lewis, Mr. J. Charles Parker II, and Mr. Lonnie Stockwell for the July 1, 2021 – June 30, 2022 fiscal year. All three expressed interest in continuing for another year. A sample contract was attached for the Board's review.

B. New Ethics Exposure Draft: Noncompliance with Laws and Regulations

AICPA requested feedback on the ethics division's proposed interpretation "Responding to Noncompliance with Laws and Regulations", and asked three questions.

AICPA requested comments by June 30, 2021. Mrs. Hutchinson discussed.

C. CPA Evolution: Accounting Program Curriculum Gap Analysis Report

NASBA and AICPA are researching what resources accounting educators will need to help evolve their curricula. 1200 surveys were sent to Accounting Department Chairs across the country, 317 responses were received.

The survey sought to determine if the following topics were being covered and to what extent: Data Analytics, Predictive Analysis, SOC, Digital Acumen, Cybersecurity, IT Audit, IT governance and IT risks and controls.

They have identified the content coverage in these areas to vary widely at both the undergraduate and graduate level and from university to university. They plan to fill

these gaps through a variety of methods; textbook publisher outreach, Academic Resource Hub, AICPA's Monthly Faculty Hour, and deeply discounted AICPA Certificate Programs.

The GAP Analysis Report was provided for the Board's review.

D. Resolution: Retiring Executive Director

Darla M. Saux, CPA retired from the Board effective April 1, 2021 after almost 8 years as Executive Director.

Upon motion by Mr. Hazel, seconded by Mrs. Lowe-Ardoin and unanimously adopted, the Board approved the following resolution:
