The meeting was called to order by Chair Mrs. Hutchinson at 9:02 a.m. on Thursday, July 28, 2022, upon motion by Mr. Bergeron, seconded by Mr. Langley and unanimously adopted.

#### I. CHAIR'S REPORT

#### A. PROC Contracts

John Charles Parker, II and George Kenneth Pavy, II both entered into 12-month PROC contracts with the Board, effective July 1, 2022 through June 30, 2023.

Mr. Leon K. Stockwell, III entered into a 6-month PROC contract effective July 1, 2022 through December 31, 2022. Mr. Stockwell is retiring December 31, 2022.

Mr. George Adair Lewis is no longer able to serve on the Peer Review Oversight Committee.

### B. Personnel

Rachel H. Jefferson was hired as Compliance Investigator 1 (AS-612) effective May 9, 2022.

# C. Market Pay Adjustments effective July 15, 2022

All classified employees who were actively employed six months prior to July 15, 2022 received a market adjustment effective July 15, 2022 ranging from 2-4%.

#### D. Performance Evaluations for Fiscal Year 2021 – 2022

Performance evaluations, due August 31, 2022, for all classified employees that were employed with the Board at June 30, 2022 will be completed by August 31, 2022.

## E. Performance Planning for Fiscal Year 2022 - 2023

All Board classified employees will receive Performance Planning (performance expectations) for fiscal year 2022 - 2023 no later than September 30, 2022, in accordance with Civil Service rules.

### F. Reminder - One Hour of Governmental Ethics Requirement for Public Servants

All Board Members (and staff) were reminded to complete one hour of education and training on the Louisiana Code of Governmental Ethics for 2022. This is an annual requirement. All Board Members and staff must complete the course prior to December 31, 2022.

# G. Reminder - One Hour of Sexual Harassment Training Requirement for Public Servants

All Board Members (and staff) were reminded to complete a minimum of one hour of education and training on sexual harassment no later than December 31, 2022.

Additionally, Act 270 of the 2018 Legislative Session requires one (1) additional hour of training for Supervisors. This training is provided by Civil Service through the Comprehensive Public Training Program (CPTP).

#### B. The Sunset Law

Act 158 of the 2022 Regular Session (previously HB 528)- effective June 30, 2022. The Sunset Law recreates 17 boards, including ours, transferred to or placed within the office of the governor.

The bill was first heard by the Senate Commerce committee on March 17, 2022, attended by Lisa Benefield, and reported favorably.

Next it was recommitted to the Committee on Senate & Governmental Affairs on May 11, 2022, attended by Caren Singleton, and reported favorably.

The bill was signed by the Governor on May 25, 2022 and extends the statutory authority for our agency's existence until July 1, 2027.

This request was deferred to Executive Session pursuant to Open Meetings Law, La. R.S. 42:17.

### G. Proposed Board Policy: 2022 CPE Extension to Complete Required CPE

A proposed CPE extension policy for the 2022 reporting period was presented for the Board's review and approval.

Upon motion by Mr. Hazel, seconded by Mrs. Alizadeh the Board approved the CPE extension policy.

Board Chair, Mrs. Hutchinson, appointed Mr. Morgan as the Investigating Officer assigned to the cases.

### H. Proposed Board Appointment of an Investigating Officer: 2021 CPE Audit Fails

For the past several CPE reporting periods, the Board has appointed an Investigating Officer to review CPE audit fail cases and offer resolution.

Board Chair, Mrs. Hutchinson, appointed Mr. Morgan as the Investigating Officer assigned to 2021 reporting period CPE audit fail cases.

#### XII. NEW MATTERS

# A. Request for Guidance re Financial Statement Affidavit

Staff have received inquiries relating to the Financial Statement Affidavit ("FSA") required by the LA State Licensing Board for Contractors ("Contractor's Board") as part of its application for a LA Contractor's license. The FSA requires, per LA R.S. §37:2156.1(c), that the preparer "declare to the best of their knowledge that the information provided in this financial statement affidavit of assets, liabilities and other information is true, correct and complete under penalties of perjury." Licensees have expressed confusion and concern over the form, including whether signing the FSA would constitute providing an attest service subject to Peer Review.

A copy of the FSA was provided for the Board's review.

# B. Request for Permission to Have NASBA Develop a Louisiana-Specific Ethical Leadership Training Program

NASBA's Center for Public Trust offers state-specific versions of its Ethical Leadership Training Program for state Boards to use as a tool in enforcement cases. Investigative staff have reviewed several cases lately in which this tool would potentially be useful.

More information on the program was provided for the Board's review.

Upon motion by Mrs. Alizadeh, seconded by Mr. Bergeron the Board approved adopting a Louisiana-Specific Ethical Leadership Training Program.

Mr. Hazel stepped out and did not vote.

## C. CPA Wall Certificate Delay

Newly licensed CPAs were emailed on May 18, 2022 regarding the delay in delivery of the wall certificates. Further research into the issue resulted in a new paper stock being ordered and used for the latest recipients; however, the calligrapher noted that the texture of the paper is different and could lead to additional spoilage, further increasing costs. Due to the rising cost and scarcity of paper, the cost of producing a wall certificate has increased from approximately \$12.00 in 2019 to over \$20.00 per certificate in 2022. Board staff is currently researching other possible solutions, including the possibility of utilizing NASBA's wall certificate service. Staff reached out to Pat Hartman and are awaiting a quote.

## D. Changes to State Travel for New Fiscal Year

The State Travel and PPM 49 Updates became effective July 1, 2022, which the Board is required to follow unless specifically exempted. Included in the update is a mileage reimbursement to \$0.62 per mile., up from \$0.58.

The State Travel Office, once again, approved our request to set the agency's meal allowance limitation for Board Members (and staff when dining with Board Members) to the same dollar limitation as provided for in La. Admin. Code, Title 52, Part I §1703, which is currently \$65.00.

The 2022-2023 Travel policy, updates and communication from Jay Dardenne's office were provided for the Board's review.

# E. Audit by Louisiana Property Assistance Agency (LPAA)

LPAA conducted a property inventory audit on July 18, 2022 in the Board's office. The audit was passed with no deficiencies. A formal report is expected to be issued by LPAA shortly.

### F. Database Update

The contract between the State Board of CPAs and Thentia USA, Inc. was approved by the Office of State Procurement on April 27, 2022. A welcome meeting was held on May 5, 2022 via video conference. Database information was provided to Thentia, with the assistance of TL Data, on May 12, 2022 for their initial review and analysis. A follow-up meeting was held on July 25, 2022 with our assigned Senior Project Manager, Stephanie Wood, to discuss the scope and implementation overview.

#### G. New Civil Service Policies

SBCPA's Telework Policy and the Optional Pay Policy both went into effect in July.

The Telework Policy was approved by State Civil Service on June 24, 2022, and became effective July 1, 2022. It establishes a formal policy, including training and guidance for teleworking.

The Optional Pay Policy was approved by the State Civil Service Commission and became effective on July 6, 2022. Ms. Benefield attended the Commission meeting in Baton Rouge. It provides optional pay to permanent classified employees under certain circumstances; to match a job offer, to reduce compression pay, recruitment of employees in difficult to fill positions, or to provide compensation for employees who perform additional duties. The additional duties can be permanent or temporary.

## H. Americans with Disabilities Act Policy

Act 103 of the 2022 Regular Session established policy, training and reporting requirements for all executive branch state agencies for purposes of compliance with the Americans with Disabilities Act (ADA).

A draft of the proposed State Board of CPAs Americans with Disabilities Act (ADA) Policy was provided for the Board's review.

Upon motion by Mr. Bergeron, seconded by Mrs. Alizadeh the Board approved the draft of the ADA Policy.

### I. Election of Officers and Appointment of Investigating Officers

#### 1. Election of Officers

Chair Mrs. Hutchinson announced an election of Board Officers as in order. The current Board Secretary was Mr. Bergeron and the Treasurer was Mrs. Lowe-Ardoin.

Upon motion by Mr. Bergeron, and seconded by Mr. Hazel, the Board elected Mrs. Alizadeh to serve as Board Secretary effective August 1, 2022.

Upon motion by Mr. Hazel and seconded by Mrs. Honoré Thomas, the Board elected Mr. Bergeron to serve as the Board's Treasurer effective August 1, 2022.
