I. CHAIR'S REPORT

A. Personnel

II. APPROVAL OF MINUTES

The regular and executive session minutes for the October 2022 Board Meeting were previously sent to Board members for review.

By motion of Mr. Bergeron, seconded by Mrs. Alizadeh, and unanimously adopted, the Board approved the October 2022 regular and executive session minutes as revised.

III. TREASURER'S REPORT

- **A.** The Louisiana Legislative Auditor completed the Audit for the fiscal year June 30, 2022 and published its report on November 22, 2022. A copy of the full report and a summary of the audit, are available on the LLA's website. The summary of the audit was presented for the Board's review.
- **B.** Financial statements through November 30, 2022 were presented for the Board's review.

By motion of Mr. Langley, seconded by Mrs. Honoré Thomas and unanimously adopted, the Board approved the financial statements as presented.

C. A proposed amended budget for the current fiscal year ending June 30, 2023 was presented for the Board's review.

By motion of Mrs. Alizadeh, seconded by Mrs. Honoré Thomas and unanimously adopted, the Board approved the proposed amended budget: revenue of \$1,017,985 and expenses of \$1,204,001 for net expenses over revenue of \$186,016; for the current fiscal year ending June 30, 2023.

A projected budget for fiscal year ending June 30, 2024 was also presented for the Board's review.

By motion of Mrs. Honoré Thomas, seconded by Mr. Bergeron and unanimously adopted, the Board approved the projected budget: revenue of \$1,042,730 and expenses of \$1,212,912 for net expenses over revenue of \$170,182; for fiscal year ending June 30, 2024.
