X. RECURRING MATTERS AND DEFERRED ITEMS

A. Society of Louisiana CPAs (LCPA)

Ron Gitz, LCPA CEO/Executive Director, reported on items of interest to the Profession, including various legislative matters.

B. New Board Rules – Effective April 20, 2023

Ms. Benefield, Ms. Singleton, and Ms. Boudreaux attended the Occupational Licensing Review Commission Meeting on March 15, 2023 in Baton Rouge, wherein the Board's proposed changes to the Rules were unanimously approved. Thereafter, the new rules became effective on April 20, 2023. There was a publishing error, which will be corrected via an editor's note and repromulgated to correct citation errors in the May 20th LA Register.

XI. CPE ITEMS

A. 2022 CPE Reporting Form Update

A certified letter was sent to 13 CPAs on April 28, 2023 advising that their CPE form was not received. It instructed them to send the form within 5 business days or their license will be switched to Inactive.

B. Professional Ethics Requirement for 2024 – Update

The Ethics Committee has advised that all CPAs who hold an active license in Louisiana must complete a 3-hour Professional Ethics course in 2024 to be eligible for license renewal in 2025.

The Board has reviewed the Ethics Course Guidelines used in 2022 and has endorsed them as the template for CPE sponsors to develop the Ethics Courses for 2024. The Board will review and select the Ethics Courses to be offered.

C. Request for Waiver or Extension of 2022 CPE due to Medical Hardship

This request was deferred to Executive Session pursuant to Open Meetings Law, La. R.S. 42:17.

D. Request for Approval of CPE for Published Material

James Anderson Koerber, CPA (License No. 14269) submitted a request for approval of CPE credit for publication of two (2) chapters in a book:

F. UAA Model Rule Changes

NASBA announced the adoption of changes to the CPA Exam Model Rule Amendment via email to Executive Directors on April 24, 2023. On April 21, 2023, the NASBA Board of Directors voted to adopt an amendment to UAA Model Rule 5-7. The amendment increases the length of conditional credit from 18 months to 30 months, bases the calculation of conditional credit for Exam sections passed on the date that scores are released, and added descriptive language to provide greater clarity for when Boards of Accountancy may extend conditional credit.
