What are the most common questions you field on the phone or via email from the public in your role as the Board's Accountant?

Most commonly, individuals reach out seeking personal accounting or tax advice—services which, understandably, fall outside the scope of the Board's responsibilities.

In such cases, I do my best to clarify our role and redirect them to the appropriate resources. While these interactions are typically brief, they serve as a helpful reminder of the importance of clear communication regarding the distinction between public sector financial operations and private accounting services.

What projects are you most proud of since you became the Board's Accountant?

One of the projects I'm most proud of is transitioning to the Thentia platform. This has been a significant undertaking that required not only adapting to a new system, but also developing new standards and procedures for reconciling daily financial activity. There's still more to learn about our new platform; however, establishing a clear, consistent process is essential to ensuring accuracy and accountability as we move away from our legacy systems.

In conjunction with this transition, I also undertook a comprehensive update of our accounting desk manual. This involves documenting the new workflows, reconciliation procedures, and system-specific processes to reflect the changes brought about by Thentia. The updated manual will serve as a reliable, up-to-date resource for both current staff and future team members, supporting continuity and operational efficiency.

What do you like about Accounting in general?

What I enjoy most about accounting is the sense of order it brings. There's something very satisfying about taking a pile of numbers and organizing them into something that makes sense—where everything ties out and tells a clear story. I like the problem-solving aspect too; when something doesn't balance, it's like a puzzle to figure out what went wrong and how to fix it.

I also appreciate that accounting plays such an important role behind the scenes. It supports good decision-making and helps keep things running smoothly and responsibly. Being part of that process, and knowing the work I do contributes to the bigger picture, is something I really value.

What are your hobbies and/or favorite things to do when you aren't at work?

When I'm off the clock, I'm either binging a show, doodling in my sketchbook, or writing stories I may or may not finish. I love trying new restaurants, hitting up festivals, and recently—Pilates has become my unexpected new favorite. But the best part of my free time? Hanging out with my 14-year-old daughter. We're currently deep into designing K-pop merch, and honestly, we take it very seriously.

BOARD DISCIPLINARY ACTIONS BY CONSENT ORDER

INFORMATION: This matter was pending before the State Board of Certified Public Accountants of Louisiana ("Board") for administrative adjudication of alleged violations of the Louisiana Accountancy Act, LA R.S. 37:71 et seq., by the Respondent, for failing to timely respond to his client relating to the preparation of a schedule K-1 form for the 2018 partnership return for St. Tammany Extended Stay Hotel, LLC. Specifically, Respondent allegedly failed to timely respond to client regarding a 2018 schedule K-1 form, which he did not mark "final".

More specifically, the Respondent is alleged to have violated the following provisions of the Louisiana Accountancy Act: LA R.S. 37:79(A)(8): Conduct reflecting adversely upon licensee's or privilege holder's fitness to perform services while a licensee.

The Respondent agreed to enter into a Consent Order to resolve the matter. Under the terms of the Order, Respondent was formally reprimanded and ordered to pay a fine of two-hundred fifty dollars (\$250).

More specifically, the Respondent is alleged to have violated the following provisions of the Louisiana Accountancy Act and Board Rules: La. R.S. 37:83(D): "No firm shall provide attest services or assume or use the title 'certified public accountants' or the abbreviation 'CPAs' or any other title, designation, words, letters, abbreviation, sign, card, or device tending to indicate that such firm is a CPA firm unless the firm holds a valid permit issued as provided for in this Part and ownership of the firm is in accordance with this Part and rules adopted by the board and AICPA Code of Professional Conduct: Part 1.600.010.02: False, Misleading, or Deceptive Acts in Advertising or Solicitations.

The Respondent agreed to enter into a Consent Order to resolve the matter. Under the terms of the Order, Respondent was formally reprimanded by the Board, and assessed a fine in the amount of One-thousand dollars (\$1,000).
